The Gypsy Vanner Horse Society will be at the Cobleskill Fairgrounds on Monday, October 10th for Evaluations. The Gypsy Vanner Horse Evaluation Program has been developed as an educational tool. The program's purpose is to help breeders and owners to educate themselves about the strengths and weaknesses of their horses so they can use this knowledge in making educated breeding and purchasing decisions. Day stalls will be \$25 for horses and \$15 for tack.

Fees

- **Class Fees**
 - \$25 for Gypsy, Gypsy Cross & Drum classes (\$20 for NEGHC members who joined by September 1, 2022)

Stalls assigned through show secretary. All manure must be placed in designated areas.

All entries not received as pre-entries (postmarked by September 8th) will incur a \$20 late fee per horse. Post Entries Accepted Day of Show.

Paypal (neghcsnow@gmail.com), cash, or checks (made out to New England Gypsy Horse Club). All checks and all payments of any kind must be closed by 2pm on Sunday October, 9th.
- **Refunds**

Refunds (minus office fees and stall fees) will be made only if an authentic veterinary certificate is received by the show secretary no later than 8:30 am October 8th.

***When a check is returned for insufficient funds, or an exhibitor has unpaid show balances or expenses, the exhibitor must reimburse the club for all funds and/or expenses incurred *within 5 days* of the initial occurrence and pay a \$25 service fee. If payment is not made within 5 days the exhibitor will be expelled or suspended by NEGHC and will be considered "Not in Good Standing". GVHS and GHRA will be notified.**

Entry Requirements

- Amateurs must present a GVHS amateur card or other proof of amateur status.
- Current copy of registration papers must be submitted with entries for all Gypsy, Drum and Gypsy Cross horses.
- Liability waivers must be completed with all requested names and signatures and must be submitted with entries.
- **Health Requirements-** Current, Negative Equine Infectious Anemia (EIA/Coggins) Test; and a rabies vaccine within the last 12 months are required for all horses. Out-of-state horse must have a coggins within 12 months and a valid health certificate (valid for 30 days following date of examination).

Stabling

- Stalls will be given in order of entries received.
- Stall fee DOES NOT include shavings. Shavings can be obtained for a fee with pre-entries or you may bring your own.
- Horses and exhibitors are only permitted on the grounds after 5pm on Thursday.
- Manure can only be disposed of in designated areas and must remain covered.
- Stalls are rubber matted.

- Directions from Northeast/New England States/New York City Area: Take New York Thruway North to exit 25A, which is I-88. Take I-88 to Exit 22 (the first Cobleskill Exit) Turn left after the ramp and turn right onto County Road 1 (also known as Mineral Springs Road). Turn Right onto Grand Street and Fairgrounds is on the right.
- Directions from Binghamton NY/Pennsylvania: Follow I-88 East to Exit 21 (it is also marked for SUNY Cobleskill). Bear to the left to Route 7. Turn right and follow Route 7 to County Road 1 (also known as Mineral Springs Road) go to Grand street, turn left and Fairgrounds is on the right.

Camper/Camping Rules

- No use of tents in the infield before the Fair. Tents must be located in a separate area from campers.
- Saturday pump out services can be scheduled for Saturday through NEGHC if notes on your pre-entry or you may contact Fred's Sanitation Service (518) 868-4233
- Permits must be prominently displayed on the windshield of camper.
- No direct hookups are allowed.
- NYS Health Department regulations must be followed.
- The camper owner is responsible for any violation/fines imposed by the Health Department.
- All campers must park in the area specified.
- No one under 18 is allowed to stay in a camper without adult supervision.
- All holding tanks must be closed.
- No dumping of wastewater (gray water) throughout the time the camper is on the grounds.
- No one is allowed to sleep in stalls.
- A separation distance of at least 10 feet must be maintained between camping units, including any add-on structures attached to the camping units including awnings and any structure. If a separation distance of less than 10 feet is maintained, then:
 - a. Charcoal grills, gas grills or other open-flame cooking devices cannot be used within 10 feet of any camping unit.
- Bonfires or recreational fires are prohibited on the grounds.
- The camper registrant is responsible for any fines or violations imposed by the County Health Department.
- Limited electric hookups are available. No generators are provided.

Definitions

1. **Age of Equine** for competition purposes is considered to be one year old on the 1st day of January following the actual date of foaling.
2. **Youth** is an individual who has not reached his/her 18th birthday as of January 1st of the current competition year. A Youth exhibitor may NOT show a stallion in hand, or under saddle, including the lead line. Youth age 12 or older may show a weanling colt in hand. No one under the age of 12 may show any horse under the age of three, including leading in a lead-line class. Any Youth exhibitor anywhere on the show grounds while riding a horse is required to wear an equestrian safety helmet that is ATSM/SEI approved. Youth must also wear an ATSM/SEI helmet while driving or serving as driving groom.
3. **Amateur** is an individual that has reached his/her 18th birthday as of January 1st of the current competition year. An Amateur exhibitor does not receive monies/reimbursement for any type of horse training in any breed or discipline. Please see the GVHS rules for more details on amateur status. Every exhibitor in this division must hold amateur status. Amateur cards must be presented at check-in. A person is considered an amateur if, regardless of their equestrian skills and/or accomplishments they have not engaged in any activities listed on the GVHS website which would make him/her a professional.
4. A **Junior horse (Jr)** is one that is five years or under.
5. A **Senior horse (Sr)** is one that is six years and over.
6. **Open** classes are open to all exhibitors (including youth and amateurs).
7. **Gypsy** Horses must be purebred and defined in Division Rules.
8. **Not in Good Standing:** Any exhibitor who fails to pay fees owed to competition management at the time fees are due or any exhibitor whom submits a check that is returned for "insufficient" funds or a "stop payment" and payment and any associated fees are not brought current within 5 days is considered Not in Good Standing. Exhibitors not in good standing will become ineligible for awards, membership voting and other membership benefits until they are paid in full. Exhibitors will not be allowed to participate in future NEGHC shows until payments are made in full.

General Rules

1. For Gypsy, Gypsy Cross & Drum Classes: GVHS Rules will be used as a guideline. The decisions of the judges/management will be final. Competitors are required to read the GVHS Show Rules prior to the show. The rule book is located at https://vanners.org/pdf_post/gvhs-show-rules-effective-1-1-2020/ .
2. All classes not specified as “Gypsy”, “Gypsy Cross”, “Drum”, or “Gypsy Cross & Drum” are open to **ALL BREEDS**: GVHS and USEF rules will be used as a guideline. The decisions of the judges/management will be final.
3. Exhibitors must be ready at the gate and enter the arena promptly. The gate will be closed two minutes after the first call for a missing exhibitor (unless otherwise notified). Exhibitors will not be allowed to enter after the gate is closed.
4. Not all of the Gypsy classes count for each registry. Please check which classes count for your chosen registry.
5. All add slips are due in the Show Office at least 3 classes before the class you are adding.
6. You must notify the office if a tack change is needed at least 3 classes prior to your class.
7. No one shall approach the judge with regard to a decision unless he first obtains permission from the ring steward or show management who shall arrange an appointment with the judge at a proper time and place. The ring steward or a member of show management appointed by the ring steward shall be present for all appointments made. No exhibitor has the right to inspect the judge’s cards without the judge’s permission.
8. **Everyone under 18 years of age must wear an approved helmet while mounted or driving at all times per NYS Law.**
9. The show management or judge(s) may and shall immediately order out of the ring or off the grounds: any person not showing sportsmanship, any person using profane language, any person displaying unsafe behavior and/or any unruly horse, habitual kicker, striker, biter or a horse not under control.
10. Cruelty to or abuse of a horse by any person is forbidden. The judge and/or show management has the authority to dismiss from the class or showgrounds, any person for cruelty to, or abuse of a horse. If a rider is disqualified from showing by the management, or by officials, or if a horse is entered and not shown, the entry fee will not be refunded.
11. Lunging and schooling must be kept to designated areas only. No schooling when trail equipment is in the ring please.
12. Horses staying overnight must be stalled.
13. Exhibitors will be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, or arising from any horse or article owned or exhibited by him/her and shall indemnify the show management and/or NEGHC and/or any agent thereof, against all legal or other proceedings, claims or demands of any kind or nature in regard thereto, or that may arise from the negligence of the person in charge of any such horse or article.
14. No Stallions will be allowed in Leadline, Youth, or Beginner classes.
15. All stallions must wear a yellow ribbon in their tails to identify them.
16. All horses that have a tendency to kick should wear a red ribbon in their tails.
17. All horses shall be show-sound. Any horse showing evidence of lameness or broken wind shall be refused an award or excused from that class and future classes on the same day. The judge has the authority to dismiss from a class any horse that is unsound. Obvious lameness will be cause for disqualification. Evidence of bleeding, either from the mouth or other areas of the horse shall be cause for elimination of that horse from that class.
18. Any saddle class having more than 20 horses in it must be split and worked in 2 sections and the top horses in each section are to be reworked for pinning. Driving classes should be split at the discretion of the show committee. Beginner and Green classes will be split if more than 14 horses.
19. A horse must be at least 3 years old to show under-saddle.
20. A horse must be at least 2 years old to show in a driving class.
21. Classes should enter the ring at a walk.
22. Being a member of the show committee does not exclude an individual from showing at said show.
23. Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accidents, or emergencies. Every effort will be made to reschedule with priority given to any qualifying classes being offered.

No refunds for cancellations due to hazardous weather, Acts of God, accidents or emergencies. Management reserves the right to change officials, limit entries, combine or cancel classes, and modify the schedule as required by circumstances to the competition specifications listed herein.

24. Classes may be added, combined, split, or deleted at the discretion of Show Management or judges.
25. All dogs must be leashed and restrained. If a dog is found to be unleashed, the owner and the dog may be asked to leave the show grounds. For safety purposes, it is strongly suggested that no dogs be near or around the show ring, entrance, and exit gate. If a dog is found to be disturbing or dangerous the owner will be asked to remove the dog from the show grounds immediately. No fees will be refunded. You MUST clean up after your dog. No dogs are to be housed in stalls.
26. Each horse will have a unique number. Exhibitors must display a visible number in all classes. Exhibitors will be given one warning regarding numbers not being visible.
27. Non-showing horses are allowed on the grounds if space is available. The owner must fill out an entry form and pay office and stall fees.

Division Rules

- **Gypsy Division**

Horses in Gypsy specific classes must be full blood Gypsy and registered with at least one of the following registries: Gypsy Vanner Horse Society (GVHS), the Gypsy Horse Registry of America, (GHRA), the Gypsy Cob and Drum Horse Association (GCDHA), Traditional Gypsy Cob Association (TGCA), Irish Cob Society (ICS), or the Gypsy Horse Association (GHA). Proof of registration must be presented with entry forms. Horses may cross enter into open classes. All GVHS registered horses need GVHS registration numbers on the entry form.

- **Gypsy Cross & Drum Division**

Horses must be registered either as a Gypsy Cross, Gypsy, or Drum in GHA, GCDHA, IDHA, TGCA, ICS, or GHRA or in a Gypsy registry. Proof of registration must be presented with entry forms. Horses may cross enter into all breed classes.

- **Green/Novice**

This combined division is for horses in their first or second year of showing at the canter or lope OR riders who have not won a blue ribbon in an open three-gait class with more than 5 entries, at any show previous to this show. Walk-Trot show years do not matter. Horses may be ridden english or western. Participation in this class does not eliminate horse/rider eligibility for walk, trot/jog classes.

- **Youth Division**

For individuals who have not reached his/her 18th birthday as of January 1st of the current competition year. A Youth exhibitor may NOT show a stallion in hand, or under saddle, including lead line. Youth age 12 or older may show a weanling colt in Halter. Any Youth exhibitor anywhere on the show grounds while riding or driving a horse is required to wear an equestrian safety helmet that is ATSM/SEI approved.

- **Leadline Division**

For riders nine years old and under. Riders with Special Needs of ANY age are welcome in our lead line division. Exhibitors can not enter any other divisions. No stallions. The horse must be led by an adult 18 years of age or older.

- **Driving**

GVHS and American Driving Society Performance rules are used as a guideline. Driving classes will be held in the covered arena unless general conditions are not suitable. Drivers are only eligible for one of the following three classes: Gentleman, Ladies, and Youth Driving. Youth drivers are not eligible in Ladies' or Gentleman's classes.

Class Rules

- Patterns are required to be posted at least one hour prior to the class.
- Gypsy Vanner Horse Society (GVHS) rules will be used for all breed-specific classes. Please review the GVHS rules in addition to our NEGHC show rules.
- Note that any riding class not listed as WT/J, WT, WJ or 2 Speed (walk, trot/jog) or Green Horse WT/J is a three-gate class, except for leadline.
- In the interest of fair & balanced competition, the same horse/rider combinations can not compete in both three-speed (walk, trot/jog canter/lope) classes and two-speed (walk, trot/jog) classes. For example, the same Horse/Rider combinations cannot show in both equitation walk/trot and equitation walk/trot/canter. If offered, the Versatility Challenge, Sidesaddle and the Green/Novice classes are the exceptions to this rule.

- **Classical Ladies Sidesaddle**
Open to non-youth riders. Judged 25% conformation and action, 25% manners and way of going, 25% rider, and 25% turnout of horse and rider. This is a walk, trot class.

- **Gypsy Champion Halter Classes**
First and second place winners, in each age group halter class, will show for Champion and Reserve Champion. The Champion horse from each gender group will then compete for Supreme Champion. Each judge will award a Supreme Champion.

- **Freestyle & Liberty**
Music must be dropped off in the Show Office upon check-in. Mark CD case with: Class #, Horse Name, Music Track # if applicable. Show Management may give an email to send Music prior to the show date. Show Management is not responsible for CD's that do not play correctly or skip, or malfunction. It is the Owner's responsibility to test music prior to the presentation with the Announcer/Music Steward.

- **Ranch Rail**
Ranch Rail measures the ability of the horse to be a pleasure to ride while being used as a means of conveyance from one ranch task to another and should reflect the versatility, attitude, and movement of a working horse. The horse should be relaxed, quiet, soft, and cadenced at all gaits. The horse should maintain a natural head carriage at each gait.

- **Disciplined Rail**
Disciplined Rail is a class that tests the skills of both horse and rider, as they execute specific gaits, transitions, and movements as requested by the judge. In this class, competitors may be asked to side pass, hand gallop (in three-speed classes), pivot, back up, lead change (in three-speed classes), extend trot, counter canter, or lope (in three-speed classes), etc.- The class is judged on performance and manners.

- **Gypsy Solid Color & Blagdon Halter**
Any age, any sex of solid color (e.g. bay, palomino, buckskin, gray, chestnut, black etc.) solid roan, or Blagdon pattern (sabino type, blue eyes are common, head and legs usually exhibit extensive white flecked or roan edges, body white may spread up from belly or flank with flecked or roan edges. May be minimally marked to almost white with colored ears). Judged 80% on quality and richness of color and 20% on conformation.

- **Gypsy Broken Color Halter**
Any age, any sex of non-solid color (tobiano). Judged 80% on quality and richness of color and 20% on conformation.

Awards TWO JUDGES AND TWO SETS OF RIBBONS. Rosettes up to 6th place in all classes **SHOW END POINT**

TABULATIONS:

1st place – 6 points, 2nd place – 5 points, 3rd place – 4 points, 4th place – 3 points, 5th place – 2 points, 6 place – 1 point. ½ point given to an entry who is the only entry in the class. Champion Halter-5 points, Supreme Champion Halter-5 points

HALTER AWARDS

There will be one Grand Champion, Reserve Champion, and Supreme Champion Horse from each Gypsy sex division per judge. The Supreme champion will be chosen by each judge from the three Grand Champion winners of their respective in-hand, Halter class.

Gypsy Champion & Reserve: Stallion, Mare, Gelding, and Gypsy Supreme Champion.

HIGH POINT HORSE AWARDS

Guidelines: Points are accumulated by the *HORSE* regardless of the exhibitor (a horse can get points with more than one rider). There are three High Point Awards, Gypsy High Point Overall, GVHS High Point Overall (winner must be a GVHS registered horse), and All Breed High point Overall. Points are awarded from the following qualifying classes:

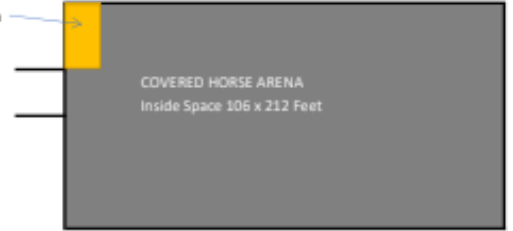

WAIVER, RELEASE OF LIABILITY, AND INDEMNITY AGREEMENT

RELEASE OF LIABILITY AND STATEMENT OF RESPONSIBILITY: I understand that neither the New England Gypsy Horse Club, (NEGHC), its officers, directors, officials, organizers, members, volunteers, trainers, helpers, employees, workers and/or agents, nor the property owners or management, accept any responsibility for accidents, damage, injury, or illness to me, or any other persons or property including equines in connection with any event, competition, show, schooling show, horse show, exposition, pleasure drive, clinic, horse activity, meetings, riding activity or any other participation in any event and/or activity by me while on any premises used by the NEGHC, or on the premises of an NEGHC member holding a NEGHC related event, or on any premises where the NEGHC may be holding a show, event or sponsoring. I hereby expressly agree for myself and my principals, representatives, employees and agents that horse sports, including spectators, drivers and riders involves an inherent risk of serious injury or death and by attending and/or participating, I do so voluntarily and expressly assume any and all risks of injury or loss, and I agree to indemnify and hold the NEGHC, its officers, directors, members, volunteers, employees and agents harmless from and against all claims including any injury or loss suffered during or in conjunction with any activity on any premises used by the NEGHC, or any members premises for a NEGHC related event, whether or not such claim, injury or loss resulted either directly or indirectly from the negligent acts or omissions of the NEGHC, it's officer, directors, members, volunteers, trainers, helpers, employees, agents, officials, and/or organizing committee. I further agree not to commence an action or suit in any jurisdiction for any such injuries or losses.

It is fully understood and agreed between the NEGHC and its members, employees, agents sponsors, volunteers, and insurers will at no time have Care, Custody, and/or Control of any animals and/or personal property whether or not exhibited, which are brought on or about the show/event grounds where the event takes place. The exhibitor or owner, it's employees, associates, and/or agents will have full control, custody and care of any animals, and/or personal property which are brought on or about the premises of the show. For the overall working of the event, the exhibitor or owner must handle and care for any animals and/or personal property in accordance with established rules and regulations. This is a waiver of your legal rights, and an agreement not to sue for serious injury or death that may result from riding or being near horses as well as acknowledging your risk of COVID exposure.

In Consideration for the New England Gypsy Horse Club allowing me or my child to voluntarily participate in its activities, I further agree as follows:

A. This agreement, waiver, and release applies to the NEGHC ,and to its Board Members, Association members, show management, committees, employees, volunteers predecessors, successors, attorneys, insurers who are working in the course and scope of their duties on behalf of the NEGHC and this show, including the city of event location, and county of event location, at the time of occurrence of any act or omission which is later alleged to be a cause or contribution to a claim for injury, damages, and death.

B. I forever release, hold harmless and indemnify Release Parties from liability for any and all claims, demands, cause of action, damages, and death to me, my minor child, my horse and my popery, and legal liability of every nature, including the negligent acts or admission of anay Release Parties, whether known or unknown, anticipated or unanticipated, direct or indirect, arising out of the participation in the past, present, or future New England Horse Club activities (including equestrian activities, such as the riding, use of or being near, horses, whether at an arena, stable or on a trail ride in association with the NEGHC) and I assume all risks of injury or death as set forth in this release;

C. I shall not bring any lawsuit, action or proceeding against any Release Parties even if the engage in negligent conduct; and

D. I make this agreement, waiver and release for and on behalf of myself, my spouse, my child and/or ward, heirs, administrators, successors, representatives and assigns.

3. Activity risk

I understand that horseback riding is a rugged adventure, recreational sport activity. I am aware that there are numerous obvious and non-obvious inherent risks of serious injury or death, or property damage, to me or my horse, which are always present in NEGHC activities, on or near horses. I understand that pregnant women are specifically advised not to ride horses.

4. Nature of Horses

I understand that no horse is completely safe, and the Release Parties make no representation or guarantees regarding the safety, training or suitability of any horse. Horses are more powerful, and faster than a human. If I fall from a horse to the ground, the impact will typically injure me. A horse may divert from its training and act according to its natural survival instincts and may abruptly change directions or speed up, trip, slip, fall, stop short, shift its weight, buck, rear, kick, bite, spook, or run from what it perceived to be danger if it is frightened or provoked, or for no reason whatsoever.

5. Conditions of Nature & Locations

I agree that Release Parties are not responsible for acts, occurrences or elements of nature or a particular location that can injure a person or scare a horse, cause it to trip, fall or react in some other manner. These elements include thunder, lightning, rain, wind, wild and domestic animals, insects, other people and horses, and wild animals which may walk, run, fly near, bite and/or sting a horse or person, irregular footing on groomed or wild land which is subject to constant change according to weather temperature, natural and manmade objects. The Released Parties have not inspected, and make no representations or warranties concerning the safety or condition of, any trail, camping site, arena and/or other location of NEGHC events.

6. Helmet Warning

I am aware that protective headgear which meets or exceeds the quality standards of USPC (Pony Club) ASTM/FEI certified equestrian helmets should be purchased and worn by me and/or my child while riding and being near horses, and the wearing of such helmets may reduce the severity of some head injuries and may prevent my serious injury or death as a result of a fall or other occurrence. If I (as an Adult rider) Do not wear a helmet, it is because I so choose.

7. COVID-19 Waiver

By signing this document, you are also acknowledging that an inherent risk of exposure to COVID-19 exists in any public place where people are present. By attending this event, you and any guests voluntarily assume all risk related to exposure to COVID-19 and agree not to hold Released Parties, Board Members or affiliates of the NEGHC liable for any illness or injury or death.

Under the NY inherent risk law (S.1152/A.559) an equine professional is not liable of injury to/or the death of a participant in an equine activity resulting from an inherent risk of the equine activity.
